Homes of Hope is a collaboration with nine congregations of devoted Catholic sisters -- Salesian; Carmelite; Franciscan Clarist; Holy Spirit; Missionary Sisters of Mary Help of Christians; Jesus, Mary, and Joseph; Sacred Heart; St. Anne; and Ursuline Franciscan. We work with the sisters to rescue, house and educate 2000+ orphan girls, the unwanted "street children" of India and assist in the education of 70,000 boys and girls, the poorest of the poor.

NEEDS SERVED BY OUR ORGANIZATION:

Our 29 currently operating orphanages and schools, ranging in size from 50 to 200 girls, are home for over 2,000 girls, with many thousands more having received temporary shelter until they could be reunited with families. We have six Homes of Hope currently under construction. All our orphanages have dormitories, classrooms, study rooms, computers, sanitary kitchens, and sanitary toilet and bathing facilities. Many have sustainable clean water harvesting and storage systems.

The needs of these children are dire to the point of helplessness:

- India is home to over 30 million orphaned and abandoned children, of which only about 0.2% are housed in registered child care institutions.
- Many children are abandoned as people cannot afford to keep their

children. In India's male-dominated society, this means that well over half of abandoned children are girls.

- The number of helpless girls continues to grow because of ethnic clashes, broken homes, and unmarried mothers with children they cannot raise.

- Some of our orphanages are for children with special needs: orphaned by AIDS, HIV-positive children, and handicapped children.

- Unless tribal girls leave their villages for education, they are practically certain to bear children early, whether married or not, with no chance but to continue the endless cycle of poverty.

Girls are given non-sectarian moral training, health and hygiene classes, and instruction in skills to support themselves, such as computer operation and handicraft skills for girls to support themselves as they grow into healthy and useful adults. Since our founding in 2007, we have prepared over 2,000 girls -- otherwise doomed to the endless cycle of poverty -- to live happy and productive lives.

EDUCATION, HEALTH AND WELLNESS:

In addition to the construction of facilities, Homes of Hope India has provided 490 scholarships for secondary and higher education.

We have provided Christmas presents, food, and medical treatment for all orphanages.

We have provided three water treatment systems and one solar power unit.
